Subject:- Clarification of Point No. 4 of departmental selection criteria of Contractual Instructors.

Kindly refer to the above cited subject.

It is informed that department has circulated selection criteria of Contractual Instructors vide their Memo No. TE/DC rate/all ITIs/Admn-II dated 29.07.2010. In this context (regarding point no. 4 of selection criteria) it is further clarified that a candidate possessing Degree / Diploma with Craft Instructor Training Course certificate will be given preference over other candidates who may have even higher qualification.

It is ridiculous that an NTC / NAC with CITS certificate holder candidate who is eligible for the post of Craft Instructor will have to pass diploma course, then degree and then M.Tech. to gain 20 score / marks in the interview in comparison to a candidate who is eligible on the basis of degree has passed M.Tech. From the heading "extra qualification over and above essential qualification" it is clear that a candidate who has attained higher qualification after attaining minimum qualification for selection is to be awarded 20 score / marks on account of attaining higher qualification after being eligible for that instructors post. As such 20 marks / score should have been awarded to the candidates with different qualifications for the recruitment of contractual craftsman instructors as under:-
