Subject: AITT will be held in January/February 2016 as per 63 trade syllabi implemented w.e.f August 2014- regarding.

Sir,

You are aware that semester system under Craftsmen Training Scheme was implemented from the session starting in August 2013. Further the syllabi of 63 trades were revised by mentor councils (MCs) and these syllabi were also implemented w.e.f. August 2014 under CTS. Accordingly, the first semester system of AITT in 63 trades (MC) has been conducted in February 2015 along with some existing trades under CTS. The two types of question Paper (Semester System) were prepared in 63 trades which doubled the work load of Trade Testing Cell at DGET Hqrs.

It has been observed by comparing the course contents of the existing and revised syllabi of 63 trades that there are only some addition and deletion of contents & there is no drastic change except to few trade like Surveyor and Architectural Draughtsmanship where the duration of the above has been reduced from two years to one year.

It is also informed that the students admitted for the session 2013-2015 had already appeared in semester I, II & III and have to appear in the semester IV exam which will be held in the month of July/August 2015. Thereafter, only failed students would be left out who are likely to appear in AITT till exhausting their permissible attempts.

In view of above, you are requested to intimate all the students that this is the last chance for them to appear in the AITT in July -2015 as per trade syllabi implemented w.e.f. August 2013. In case, if the students failed in any subjects then they will appear in Jan/Feb AITT-2016 as per revised syllabi of 63 trades by the mentor councils and question papers will be supplied accordingly. You are also requested to give wide publicity in the News Papers and Social Media for the awareness among the students who were admitted before August 2014.
