I am directed to refer to the subject noted above and to say that the matter regarding formulation of the Haryana State Litigation Policy is under active consideration with the Government. It has come to the notice that number of writ petitions are filed only seeking a directions for disposal of the pending representations or legal notices, which are not decided in a time bound manner and then, for non compliance of the directions, within the time granted, contempt petitions are filed resulting unnecessary litigation. Further, old admitted cases may have either become infructuous or covered by any judgments of the Hon'ble Supreme Court or the Hon'ble High Court. The Government have, therefore, decided that the representations or legal notices received in the departments shall be disposed of in a time bound manner and the directions issued by the Hon'ble Court should be complied with, within the stipulated time as granted in this behalf. It is also directed to identified the cases which may have either become infructuous or covered by judgments of Hon'ble Supreme Court or Hon'ble High Court and to apprise the Registry of the High Court through Advocate General, Haryana for listing such cases on priority. You are, further directed to get the password issued for taking access to E-diary programme developed by the High Court.

2. These instructions may be brought to the notice of all the concerned. Any lapse in not comply with these instructions shall be viewed seriously.
