Dear Sir,

I would like to draw your kind attention to the excess drawl of General Provident Fund advances by Haryana Govt. employees, thereby resulting in minus balances in their respective GPF accounts.

Despite repeated requests by us at different platforms, the DDOs are still sanctioning advances from GPF in excess of permissible amounts without verifying the actual balance standing to the credits of subscribers at that time resulting in minus balances in their respective accounts. A list of fresh and pending minus balance cases relating to the department under your control is attached. In some cases, the minus balance may entail loss to the state exchequer as the recovery may become very difficult in case of death, retirement etc. of the subscribers.

I shall be grateful if you kindly direct all the sanctioning authorities again to exercise requisite vigil at the time of sanctioning of drawls from the GPF so that the drawls over and above the available balances are avoided. Also, the DDOs may kindly be directed to recover the amount already drawn in excess and deposit the same immediately in their respective GPF accounts so that minus balances may be wiped off.
