As you are aware that Beti Bachao Beti Padhao Scheme was launched by the Hon'ble Prime Minister on 22-01-2015 at Panipat in Haryana to address the issue of the declining Child Sex Ratio (CSR) and related issues


of disempowerment of women over a life cycle continuum. The programme has now being extended to in all the districts except Mewat by Govt. of India.

In this context, it is intimated that following interventions are required to be taken as per approval of Hon'ble CM, Haryana on 03.06.2016: -

Sr. No.	Intervention	Action to be taken by
1.	Women are amongst very vulnerable sections in any social order. In today's world, there is immense increase in the use of Internet in every field of the society and due to this increase in usage of Internet, a number of new crimes have evolved. Such crimes where use of computers coupled with the use of Internet is involved are broadly termed as Cyber Crimes . Therefore, a dedicated unit comprising women employees may be set up in the Cyber Crime Cell.	Home Department
2.(a)	In order to create awareness among masses and to promote gender it is proposed that Education Department may be requested to recognise Gender champions in all schools & colleges. Children/youth who come forward to the cause may be rewarded. Education Department may be requested to formulate scheme for giving encouragement & appropriate opportunities to these Gender champions at Secondary/Primary & Higher Education level. (b)	For retention of girls in secondary/High schools availability of a functional toilet is a major requirement for girls. Therefore, in order to increase enrolment and retention of girls in schools, there is necessity for functional toilets. availability of sanitary	Education Department

3.(a)	To give recognition to widows & ensure protection of their legal rights, name of alive spouse may be written on death certificate.	Urban Local Bodies
(b)	At the time of Marriage Registration, the newly married couple may take oath on affidavit that they will not commit female feticide and will give equal opportunities & affection to both son's & daughter's.	
4.	The Scheme is envisaged for focused interventions to improve the CSR, within an overall National Strategy for Beti Bachao Beti Padhao. Recognizing that the issue of decline in Child Sex Ratio is complex and multi-dimensional, it shall be addressed within the broad framework of survival, protection and education of girl child. Awareness with respect to Gender Issues may be made a regular & integral part of the trainings provided to PRI representatives by the Panchayati Raj Department.	Panchayati Raj Deptt.
5.	Awareness generation on child sexual abuse through "Komal" Video available on 'youtube' by showing it as message in cinemas before and between Films, in Child Care Institutes (CCI's), Hospitals, schools & railway stations etc. It would help in generating awareness.	DIPR
