

ORDER

In pursuance of Haryana Government Notification issued vide Chief Secretary letter No. 6/7/2014-1GS-1 dated 18.06.2014 in amendment of Govt. letter on dated 19.8.2014 and U.O. No. 6/26/2015-1GSI dated 03.6.2016. The service of the following Crafts Instructor working in contractual basis who have completed three year service on 29.6.2014 are hereby regularized w.e.f. 30.06.2014 subject to the condition that the integrity of any official for the year 2014-2015. It is further subject to fulfillment of eligibility conditions mention in the notification dated 18.6.2014 the Director, Industrial Training Department, Haryana is pleased to appoint you against a temporary post of following Crafts Instructor in the pay band of Rs. 9300-34800+ Grade Pay 3600 plus usual allowances as sanctioned by the Haryana Government from time to time:-

The Terms and Condition of appointment are as under:-

1. Your appointment is on a purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer at permanent vacancy can be made to you at present and in this respect you will have to take your chance like others who have been similarly recruited. Consequently, your services may be terminated without notice whenever there is no vacancy against which you can be retained.
2. If, at any stage you desire to resign, you will be required to give one month's notice or forfeit in lieu thereof, your salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to you by this department also, in case it is proposed to terminate your services for the reason other than that mentioned in clause (i) above.
3. You will be on probation for a period of two years, which can be extended further, but not exceeding total three years. In case, your work and conduct is not found satisfactory during the period of probation, your services are liable to be terminate forthwith without assigning any reason.
4. No travelling allowances will be admissible for joining on the post.
5. Your services can be utilized anywhere in the State/Country.
6. As your character and antecedents have not been got verified in terms of Government instructions issued vide Memo No. 52/3/2005-6S (I) dated the 18th the November, 2005, therefore, it is made clear to you that in case subsequently any adverse facts



- come to the notice of the State Government regarding your character and antecedents, your services will be liable to be terminated without giving any notice.
7. You will not undertake higher studies of any kind, without obtaining prior permission of the competent authority.
 8. This offer of appointment is subject to the condition that in case you are married, you have only one living spouse and if you are unmarried, you shall have to furnish a declaration immediately after marriage regarding non acceptance of dowry by you, to this office as per declaration in Annexure A and B in terms of Government instructions issued vide no. 18/1/2004-2GSI dated the 21st February, 2006.
 9. This offer is further subject to the condition that in case you are married, you have one living spouse and you are not married to a person who has more than one living spouse and if you have more than one living spouse, you should justify the circumstances for that.
 10. This offer is further subject to the condition that the documents pertaining to your academic/professional qualification, experience, age and caste/category etc, as claimed by you are yet to be checked/verified from the concerned authorities regarding their validity, genuineness and equivalence to the prescribed qualification & eligibility and in case during inspection/verification any adverse facts come to the notice of the Department, your services will liable to be terminated any time, without any notice besides taking criminal action against you, for which you will be wholly responsible. Therefore, you will have to bring and deposit all original documents before joining on the post for checking/verification to the concerned Principal/Incharge.
 11. You shall have to furnish a medical certificate from Chief/Principal Medical Officer concerned as required under rule 3.1 of the Punjab C.S.R. Vol. I Part-II, before your resume duty.
 12. The above offer of appointment is further subject to Haryana Industrial Training Department HQ (Group-c) Service Rules, 2013 and all other rules and regulations and executive instructions issued or to be issue by the State Government from time to time.
 13. This appointment letter is being issued subject to the out come of CWP No. 17206 of 2014 Yogesh Tayaqgi and another V/s State of Haryana and others filed in Hon'ble Punjab and Haryana High Court challenging the regularization policy.
 14. Immediately on your joining, you will be required to take an oath of allegiance to the Indian Republic in the following manner:-

I ----- do swear that I will be faithful and bear true allegiance to India and to the Constitution of India as by law established and I will carry the duties of my office loyally, honesty and with impartiality to help the Government".

If the above terms and conditions are acceptable to you, you should report for duty to the concerned Principal within a period of 15 days from the receipt of this letter, failing which it will be presumed that you are not interested to accept this offer and this offer of appointment shall be deemed to have been automatically cancelled.
