Sub : Upward revision of the annual parental income ceiling under the Centrally Sponsored Scheme of Post-Matric Scholarship for Scheduled Caste students w.e.f. academic session 2013-14.

1. I am directed to refer to the above mentioned subject and to say that as per the above scheme, the income ceiling would be revised once in every two years linking it with the consumer price index for industrial workers for the month of October of the year, preceding the year of revision and will be made effective from April.
