Sanction of Governor of Haryana is hereby accorded to the payment of **Rs. 129.30288 Lakh (Rs. One Crore Twenty Nine Lakh Thirty Thousand Two Hundred Eighty Eight only)** as "Grant-in-aid to Societies"(details shown in enclosure) towards the Non recurring expenditure of registered Industrial Training Institute Societies during the financial year 2014-15 with the following conditions:-

1. The amount will be drawn by DDO of Directorate of Industrial Training Department Haryana and the payment will be made to the societies either by Demand Draft or transfer of funds in account of respective ITI societies.
2. The funds should be utilized for day-to-day functioning of ITI and for the trades not covered under the project as per instructions contained in PFR as applicable to Haryana.

4. The Indian Audit Department shall have the right of access to the grantees books of account for which reasonable prior notice would be given by the Audit department.
5. Separate account should be maintained for the expenditure incurred out of this grant to ensure that it is utilized for the specific purpose for which it is sanctioned.
6. The expenditure involved is debit able to the Head "2230-Labour & Employment -03-Training - 003 - Training of Craftsmen & Supervisors - 69 - Grant-in-Aid to Societies" Plan for the year 2014-15.


