- a) Separate case for 4th Quarter for those SC candidates (admitted in Aug. 2015) whose Post Matric Scholarship has already been released for the period Aug. 2015 to April 2016 (3 Quarters).
- b) Separate case for 4th Quarter for those SC candidates (admitted in Aug. 2014 – 2nd year students) whose Post Matric Scholarship has already been released for the period Aug. 2015 to April 2016 (3 Quarters).
- c) Separate case for all the four quarters (Aug 2015 to July 2016) for SC Candidates (admitted in Aug. 2015) whose Post Matric Scholarship not released as yet.
- d) Separate case for all the four quarters (Aug 2015 to July 2016) for SC Candidates (admitted in Aug. 2014) whose Post Matric Scholarship not released as yet.

Kindly ensure that the sanction order and E-file pertaining to Post Matric Scholarship Bills for the above cases be submitted before due date i.e. 12/08/2016. For any further delay Nodal Officer/Principal will be held responsible and administrative action shall be taken against the defaulter.

2. Before sending the bills to this directorate must follow all the instruction given by Training Branch at Head Quarter time to time and in addition to this also check the following instructions:
- a) Bills of private ITIs in your district as per the instruction of Training Branch Endst. No. T-1-36012/1/1/30/2015 dated 19-08-2015, point no. 9 "वर्ष 2015-16 से यह निर्णय लिया गया है कि किसी भी संस्थान में कोर्सवाइज भरी गई कुल सीटों में से छात्रवृत्ति के लिए 40 प्रतिशत छात्र पहले आओ पहले पाओ के आधार पर ही छात्रवृत्ति के पात्र होंगे इससे अधिक अनुसूचित जाति के छात्रों को छात्रवृत्ति स्वीकृत नहीं की जायेगी"
 - b) Aadhaar Nos. seeding with bank accounts of each beneficiary on website <https://resident.uidai.net.in/check-aadhaar-linking-status> and <https://indane.co.in/chkaadhaarweb.php> who is the part of bill, the status of beneficiary Aadhaar No. these websites must be in **active state**. If any beneficiary's Aadhaar No. is not seeded with bank account, don't include that particular beneficiary in the bill.
 - c) Email related to PMS Bills must include the sanction orders, E-file (DR-CR file) in excel format and scanned copy of E-File (DR-CR File) duly verified by the Nodal Officer and signed by the employee who prepare and checked the E-File with their name, designation and mobile no.

Send the data to this directorate by following the above direction on and before the 12/08/2016. For any further delay, Nodal Officer/Principal will be held responsible.
