Kindly refer to the subject cited above.

The Governor of Haryana is pleased to approval for the formulation and implementation of the scheme namely "Scholarship to Scheduled Castes students studying in Govt. ITI's." This scheme will be implemented through Skill Development and Industrial Training Department, Haryana from the year 2017-18 subject to the condition that the amount will be spent after making the budget provision for the year 2017-18.

Name of the Scheme: "Scholarship to Scheduled Castes students studying in Govt. ITI's."

#### 1. OBJECTIVE

The objective of the scheme is to promote the interest of skill development trainings in Scheduled Castes youths and to enable them for self employment and getting jobs in Private & Govt. Sectors.

#### 2. CONDITIONS OF ELIGIBILITY

1. The Scholarship will be given to all Scheduled Castes students who are studying in Govt. ITI's situated in Haryana State.
2. The student should belong to Scheduled Castes of Haryana.
3. Student should be resident of Haryana State.
4. The students taking benefits of this scheme will not be eligible to get benefit under any other State/Central Scheme.
5. Scholarship will be provided Aadhar linked Bank account of the student.

#### 3. RATE OF SCHOLARSHIP

Scholarship @ Rs. 200/- p.m. will be given each academic year. In addition to this, Rs. 15/- p.m. as tuition fee will be reimbursed.

Note: No scholarship will be given to failure students.

#### 4. PAYMENT

Scholarship will be given in two installments in each academic year. First installment (50% amount) will be given after taking the admission in Govt. ITI's and second installment (remaining 50% amount) will be given subject to fulfillment of attendance criteria for appearing the examination.

#### 5. MODE OF DISBURSAL OF SCHOLARSHIP

In order to ensure timely payment of scholarship, the payment of scholarship will be made to students through their Aadhar linked bank account instead of cash payment.

### 8. PROCEDURE FOR APPLYING

An application for scholarship should comprise:

1. An application for scholarship will be given to the Head/Principal of ITI's.
2. One copy of passport size photograph with signature of the student.
3. One attested copy of Caste certificate/Haryana resident certificate.
4. An affidavit will be given by the student that he will not take benefit under any other State/Central scheme.

The expenditure under this scheme will be met out from the Head "2225-Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities-01-Welfare of Scheduled Castes-277-Education-67-Scholarship Scheme to Scheduled Castes students studying in Govt. ITI's-51-NA-12-Scholarship and stipends"(NR) for the year 2017-18.
