The sanction is issued with the following terms and conditions:

1. On the basis of above particulars the monthly financial assistance will be admissible commencing from 20.09.2016 to 30.4.2017 under rule 5(i) (c) of Ex-Gratia Scheme, 2006.
 2. The family shall be eligible to receive family pension as per the normal rules only after the expiry of the period during which she will receive the Financial Assistance as above.
 3. The house Rent Allowance shall not be a part for the purpose of calculating the Financial Assistance .
 4. The claimant shall open an account with any of the Nationalized Bank and the payment of above Financial Assistance will be made through Bank draft or by cheque through Bank transfer every month by the concerned DDO.
- 1 The expenditure will be met out of the Budget Grant under the Head "2230-labour and employment-03-Trg.-003-Training of Craftsmen &

- supervisors Development of Industrial Training Institutes (64) Plan Ex-gratia grants to the legal heir of the deceased Govt. Employees .
- 2 The govt. accommodation if any allotted to the dependent of the deceased govt. employee and it has been allowed to be retained for one year more to dependent of the deceased after his death by the competent authority than license fees of govt. accommodation will be deducted from this financial assistance.
