**Subject: Approval of 05 grace marks in any one paper of both semesters of CITS Examination – req.**

Sir/Madam,

This is to inform that meeting of "Sub-Committee of NCVT on Norms and Courses" was held on 23<sup>rd</sup> March, 2018 at 3<sup>rd</sup> floor, KaushalBhawan, Pusa Road, Karol Bagh, New Delhi under the Chairmanship of DG / Additional Secretary, MSDE.

The approval of 05 grace marks in any one paper of both semesters of CITS Examination was discussed as agenda item No. 10 in the above meeting.

Member was informed that the passing percentage in theory for CITS examination is 60% and no supplementary exam provision is available under the scheme. To support such trainees, provision of 5 marks as grace mark in any one paper of both semesters has been approved by the Sub- Committee on the following condition:

- If a trainee fails in two papers of same semester, then grace mark would be provided to any one paper, so as to get passed mark but he/she has to re-appear for other paper even failed by 5 or less than 5 marks in this paper.

The Sub-committee also directed to indicate the allotted grace marks on "Mark Sheet" and maximum grace marks should be decided by the examination committee. Sub-Committee also approved the provision of grace mark for trainees who had re-appeared to session of year 2016-17 also.

The above norms for grace mark shall be also allowed for CITS trainees who had re-appeared for examination to session of the year 2016-17 onward.
